Ann G will be delivering the extra newsletters to the Town Hall, Library and Cyndi's keeping some for the meeting.

A boosted facebook post was approved for the annual meeting.

Paypal is ready to launch on the website and facebook once the non-profit status is approved by facebook for the lower fees.

The Board approved not to pass on the additional costs for this year that the RPA will have using Paypal for contributions. Additional costs are approximately 3%.

Pricing for the new visors and baseball hats were discussed and approved. Visors \$15, Hats \$17. T-shirts are still \$5.

Robert L thought we should look into getting decals / bumper stickers to give away. Someone will look into that after the Annual Meeting.

It was agreed that until we have someone who is willing to do fulfillment, we will not be having any online sales of shirts, hats or visors.

We need two board members for our open positions. After the annual meeting, the current president will call for a board meeting to vote for the executive board.

Sandy M will mail a check to the State so we can receive the signs necessary to be posted at the boat launch and at Cyndi's concerning lake hazards. These are needed for liability issues.
